Construction of fibre optic networks in Brinckmansdorf, Kessin and Kühlungsborn

Stadtwerke concludes contract with VitrumFiber

Fast Internet is coming to Brinckmansdorf, Kessin and Kühlungsborn. Together with its partner VitrumFiber, Stadtwerke Rostock is starting the expansion of a fibre optic network. The two companies signed a contract for this last week. VitrumFiber will build modern broadband networks in the municipalities and Stadtwerke Rostock AG will operate the networks.

"In our enquiries, more than 40% of potential customers have indicated a need for fibre optic connections," says Stefan Waldhaus, Head of Smart Region at Rostocker Stadtwerke. "Now that the contract has been signed with our partner VitrumFiber, we can get started with the construction work in the short term," Waldhaus continues. The energy service provider can connect up to 3,900 customers in the Kühlungsborn expansion area and 3,300 customers in Brinckmansdorf and Kessin.

Andreas Marschall, Managing Director of VitrumFiber, explains: "We are very pleased to be able to support our partner, Rostocker Stadtwerke, in expanding the fibre optic network in Brinckmansdorf, Kessin and Kühlungsborn and thus laying the foundation for high-speed Internet for the customers of Stadtwerke. We are building the modern fibre optic infrastructure and leasing it to the municipal utilities, which will then take over the supply to customers."

The energy service provider has been offering fibre optic connections primarily to commercial customers for six years.
